As a part of this agreement, Augustana pledges to the student that they will receive the following benefits for participation.

- Access to the benefits afforded all [part-time students](#)

- Participation in two 4-credit courses at the tuition rate of your home institution. Courses will typically be a Reasoned Examination of Faith (REF) course and a course fulfilling the diversity requirement (D).

Student Agreement

As a participant in the Augie Next Program, I understand and will adhere to the following parameters of the program.

- I will continue to enroll as a full-time student at my home institution.
- I will pay all tuition and fees associated with the program to my home institution in accordance with their billing and fees policies and timeline.
- I will enroll in the two Augustana courses as advertised and offered and complete the work with a passing grade.
- I understand the coursework taken at Augustana will be considered transfer coursework at my home institution and is subject to those academic policies.
- I will be considered a part-time non-degree student at Augustana until the point I have completed the requirements at my home institution and have been accepted as a degree-seeking transfer student at Augustana.
- I will adhere and are subject to all Augustana policies contained in the college catalog, the Academic Calendar and the student handbook, and the consequences of violating these policies.

I agree to the stipulations noted above and within the policies noted in the Augustana Catalog for this program. I understand that a breach of any of these requirements may be cause for my dismissal from the program by either my home institution or Augustana College and I will forfeit any fees I have paid.
